

Consent to the processing of personal data

The company **IGNIT, a.s.**, ID number 275 75 063, with its registered office at Českobrodská 1174, Kyje, 198 00 Prague 9, registered in the Commercial Register of the Municipal Court in Prague, file no. No. B 10913, email: _____ (hereinafter referred to as the "**Administrator**") hereby, as the administrator of personal data in connection with the granting of your (hereinafter referred to as the "**Data Subject**") consent to the processing of personal data as a data subject, informs you in accordance with regulation article 13 et seq. Regulations of the European Parliament and of the council (EU) No 2016/679 of 27 April 2016, the General Regulation of the Protection of Personal Data (hereinafter "**GDPR**") on the principles for the protection of personal data.

In connection with the provision of the Administrator's services, in particular the closing of a contract for the lease of means of transport, the Administrator will process the personal data of the Data Subject for the following purposes:

- identification of the Data Subject (first name, surname, date of birth, permanent residence address, telephone number, e-mail address);
- closing the contract for the lease of means of transport;
- fulfillment of the necessary obligations in the scope of: photographed ID card and driver's license,
- GPS coordinates of vehicles;
- photograph of Data Subject of these documents in the form of selfie in the car

The legal basis for the processing of personal data of the Data Subject is therefore the performance of the contract for the lease of a means of transport, the legitimate interest of the Administrator, as well as any obligations arising from torts and unjust enrichment.

Personal data will be processed for the time strictly necessary, which is until the termination of the contractual relationship established by the contract for the lease of means of transport, or until the revocation of consent of the Data Subject. All documents provided will then be deleted.

Personal data of the Data Subject may be provided to the Administrator's software service providers for the purposes of proper settlement of the contractual relationship, as well as to persons providing legal and accounting services for the Administrator in order to ensure proper fulfillment of obligations arising from subcontracts and obligations stipulated by generally binding legal regulations.

The Administrator does not intend to transfer the personal data of the Data Subject to a third country, an international organization or anything other than the above-mentioned third parties. There will be no automated decision-making or profiling when processing personal data of the Data Subject.

The Data Subject has the right to request access from the Administrator to his personal data, their correction or deletion, or restrictions on processing, and to object

to the processing, has the right to transfer this data to another Administrator, as well as the right to file a complaint with the Office for Personal Data Protection if he believes that the Administrator is acting in violation of GDPR when processing personal data. The Data Subject has the right to revoke this consent at any time, for example by sending an appeal to the above-mentioned contacts.

The Data Subject also hereby consents to the processing of the photocopy of the sent ID card in accordance with the provisions of Section 15a, Paragraph 2 of Act no. No. 328/1999 Coll., on identity cards, as amended.
